

Minutes of Meeting of Miami Valley Folk Dancers Council, 10 October 1962

The meeting was held at the home of Rose Marie Danehy, 817 Hampshire Rd., 10 October 1962, 8:45 pm. The meeting was called to order by the Chairman, Sara Fleischer. Those present were: Sara Fleischer, Rose Marie Danehy, Jack Hunter and Mitzi Manny (Council members). Ed Preis was absent. Libby Ogdan, Treasurer, was present; and Grace Wolff looked in for a few minutes after the meeting was under way.

The minutes of the meeting of 26 April 1962 were read. After they had been approved, Sara Fleischer gave a recap of items of business which had been discussed at that meeting, as follows:

- a) Mailing list - Kaye Merrill, Grace Wolff and Sara Fleischer met in May to weed out Grace Wolff's mailing list, the purpose being to formulate a mailing list for the club which would cover an area from which we could expect to draw for institutes and weekends. Grace Wolff plans to type the 3 X 5 cards and will do this immediately after the Christmas mail has come in, so that the addresses will be as current as possible, and in ample time for the mailing pertinent to the Dunsing weekend in February 1963.
- b) Repertoire - Grace Wolff has made out cards to find out which dances of those chosen by the Council members in June to be included in the repertoire, need to be taught and/or reviewed. If the repertoire dances are to be taught at the 8:00 pm time, the Council recommended that Grace announce a week in advance just which dances will be taught and/or reviewed, so that those who need the instruction can make a special effort to be there at that time.

The minutes of the meeting of 31 July 1962 were read and approved.

The Chairman called for a report from the Treasurer, Libby Ogdan. Libby reported on the finances of the club since the beginning of the year, as follows:

Dues and guest fees received:	\$424.80
Current balance in checking account:	47.81 *
Current balance in savings account:	<u>432.98</u>

Total current balance \$480.79

* \$13.21 of the money in the checking account belongs to the flower and gift fund.

Rose Marie Danehy reported that the balance in the flower and gift fund is now \$23.21. The Chairman plans to go over the records and review them with Libby Ogdan.

The balance of the meeting was given over to discussion of the Rules and Regulations of the club. It was decided that the single sheet

of rules and regulations, was revised at the meeting of 31 July 1962, would be presented to the group at the annual meeting. It was also decided that a document entitled "Method of Operation", which is descriptive of the functions of the officers of the Council, and other details, would be brought before the group at the annual meeting in January 1963, and would be read into the minutes. The revised Rules and Regulations and the Method of Operating represent the combined efforts of Dick Weaver and his committee, appointed for the purpose of revising the rules and regulations, at the last annual meeting, and the members of the Council.

The meeting was adjourned at 11:50 pm.
